Kondisi Hygiene Sanitasi Pedagang Kaki Lima Di Terminal Magetan

Pedagang kaki lima merupakan pedagang atau orang yang melakukan kegiatan atau usaha kecil tanpa didasari atas ijin dan menempati pinggir jalan (trotoar) untuk menggelar dagangan. Tujuan penelitian ini yaitu untuk mengetahui kondisi hygiene sanitasi pedagang kaki lima di Terminal Magetan.

Penelitian ini termasuk penelitian deskriptif Metode penelitian dengan menggunakan pendekatan kualitatif dengan metode observasi, dan wawancara. Penelitian ini menggunakan pendekatan cross sectional yaitu jenis penelitian yang menekankan pada waktu pengukuran atau observasi data dalam satu kali pada satu waktu yang dilakukan pada variabel terikat dan variabel bebas.

Hasil penelitian ini menunjukkan bahwa hasil dari analisis kondisi lingkungan/lokasi pedagang kaki lima didapatkan hasil 71% kategori kurang baik, 29% dan kategori cukup baik, hasil dari analisis kondisi personal pedagang kaki lima didapatkan hasil 72% kategori cukup baik dan 14% masing-masing dalam kategori baik dan kurang baik, hasil dari analisis kondisi peralatan pengolahan pedagang kaki lima didapatkan hasil 100% kategori baik, hasil dari analisis kondisi tempat pengolahan makanan pedagang kaki lima didapatkan hasil 71% kategori kurang baik dan 29% kategori baik, hasil dari analisis kondisi makanan yang disajikan didapatkan hasil 57% kategori baik dan 43% kategori kurang baik.

Kesimpulan dari penelitian ini menunjukkan bahwa kondisi hygiene sanitasi pedagang kaki lima di Terminal Magetan seluruh hasil analisis cukup baik. Saran penelitian petugas kesehatan lebih meningkatkan dalam memberikan informasi melalui leaflet, poster, penyuluhan tentang hygiene sanitasi makanan.

Hygiene Conditions in Street Vendors at the Magetan Terminal

Street vendors are traders or people who carry out activities or small businesses without being based on permission and occupying the curb to hold a trade. The purpose of this study was to determine the sanitary conditions of street vendor sanitation in Magetan Terminal.

This research is a descriptive research method of research using a qualitative approach to the method of observation, and interviews. This study uses a cross sectional approach which is a type of research that emphasizes the measurement or observation of data at one time at a time carried out on the dependent variable and the independent variable.

The results of this study indicate that the results of the analysis of the condition of the environment / location of street vendors obtained results 71% of the categories are not good, 29% and the category is quite good, the results of the analysis of the personal conditions of the street vendors obtained 72% of the categories are quite good and 14% respectively respectively in the good and bad categories, the results of the analysis of the processing equipment conditions of the street vendors obtained 100% results in the good category, the results of the analysis of the conditions of the food processing places for the street vendors obtained 71% in the poor categories and 29% in the good categories, the results of the analysis the condition of the food served is 57% good and 43% bad.

The conclusion of this study shows that the sanitation conditions of street vendors in Magetan Terminal all of the analysis results are quite good. Research suggestions for health workers to improve in providing information through leaflets, posters, counseling about food sanitation hygiene.
